- 2. The maximum payload shall not exceed the value given in the Approved Values section of this ECC.
- 3. The trailer shall not be used on track conditions in excess of those given in the Approved Track Conditions section of this ECC.
- 4. The trailer speed shall not exceed the values given in the Approved Maximum Speeds section of this ECC.
- 5. The trailer exceeds plant gauge, see Machine Data section of this ECC.
- 6. The trailer cannot be relied upon to activate train operated points.
- 7. Personnel shall not be transported on the trailer
- 8. Not to be used ALO on LU
- 9. The machine is suitable for on/off-tracking, traveling and working under live OLE
- 10. The machine shall not be used in live conductor rail areas
- 11. The trailer shall not be used predominantly in enclosed locations
- 12. Hydraulic braking system may be used if the host machine is not compatible with the air brake system, though if the host machine is compatible, the air brake system must be used
- 13. The trailer can be on/off tracked in laden condition in accordance with the safe system of work and subject to not exceeding the Safe Working Load of any lifting equipment, including chains and lifting points.
