Maintenance Plan Details

Rexquote T16 Trailer Pneumatic/Hydraulic Braking, Rail Mounted Trailer Operating and Maintenance Manual, RQM 50109, Issue 2, 08th June 2016.

Limitations of Use

- The trailer shall only operate inside possessions.
- 2. In travelling and working modes, the trailer is within W6a gauge, as defined by RIS-1530-PLT.
- 3. The trailer shall not on/off track or work on live conductor rail lines.
- 4. The trailer may on/off track, travel and work under live OLE in conjunction with a safe system of work as determined and authorised by taking guidance from the requirements of GE/RT8024.
- 5. The trailer may not activate train operated points.
- 3. The trailer shall not travel or work on track with:
 - > cants greater than 200mm; gradients greater than 1:25; and/or curves less than 80m.
- 7. The trailer cannot be on/off tracked in the laden condition.
- For on/off tracking, a site specific plan shall be used taking account of the requirements of the applicable Module in Network Rail Infrastructure Plant Manual NR/Plant/0200.
- 9. In travelling and working mode the trailer shall be the subject to limitations of the towing vehicle.
- 10. The trailer payload of 20tonnes shall not be exceeded.

- 1. Rexquote 4-wheel trailer with 5m bed to work with compatible RRV.
- Rexquote Serial No. 2445. L&W Fleet No. RRT 35.
- Fitted with air/hydraulic spring-operated emergency/parking brake and air/hydraulic operated service brake.
- 4. Air parking brake release pressure 5 bar; service brake pressure 0-10 bar.
 - Hydraulic parking brake release pressure 25bar; service brake pressure 0-140bar.
- 5. Gross weight: 22.72tonnes.
- 6. Trailer payload: 20tonnes.
- 7. Tare weight: 2.72tonnes.
- 8. Maximum speeds (travel and working) not to exceed:
 - > 10mph plain line;
 - > 5mph switches and crossings;
 - > 1mph raised check/guard rails.
